**Personal Information and Application for membership**

The Douglas County Rifle and Pistol Club, Incorporated, is a not-for-profit recreational club incorporated in the State of Kansas and recognized by the Internal Revenue Service as a tax-exempt recreational organization. The Club is handicapped accessible. All persons in the range must have hearing protection and eye protection at all times. Rimfire rifles and handguns, and centerfire handguns up to .45-caliber are allowed. Rifles that use centerfire handgun cartridges are permitted. Black powder shooting is not permitted due to ventilation considerations. Only "bullseye" shooting is allowed. Combat and extreme rapid-fire shooting is prohibited. All centerfire ammunition must not exceed a nominal 1200 fps muzzle velocity. The range officer has the absolute discretion to disallow the use of any ammunition that the range officer believes to exceed the limitations of the range rules. All persons using or visiting the Range are covered by a \$500,000 liability insurance policy. Membership in the Club is open to any member of the general public meeting the following conditions: 1) minimum of 18 years of age (children 12 years of age if parent or legal guardian has family membership *and* is both present and supervising the child during use of the Range); 2) no felony adjudications/convictions as adult or juvenile; 2) no misdemeanor adjudications/convictions as adult or juvenile involving misuse of firearms; 4) no legal prohibition against possessing firearms by either State of Kansas or United States.

**NOTE:** Members pay a 50-cent range fee each time they use the range to defray the cost of targets. This fee is built into the "Per Visit" charge.

Memberships are for the calendar year, January 1st-December 31st. Membership dues for **new** members paid after June 30th will be half the listed amounts. Dues for renewing members are due during January. Dues for NRA members are reduced by the cost of NRA membership because the NRA provides subsidized range liability insurance if 50% of members are NRA members. You are not required to join NRA, but since we are unable to afford insurance unless we have sufficient members in NRA, this fee reduction has been enacted to reflect the total expenditure of those members who have joined NRA.

You must provide proof of current NRA membership to take advantage of reduced rates. Your membership card, NRA confirmation number (if you just joined), or the mailing label from one of the NRA magazine titles will be accepted. If you do not have either, you will be charged the higher rate and will receive a refund by check upon producing evidence of NRA membership. The Club has discount coupons for NRA membership- ask the Range Officer.

**ALL** users new to the facility are required to participate in the Friday evening (5:45PM) orientation session.

You will need your own hearing/eye protection, plus firearm and ammo. A Range Safety Officer will inspect your firearm, your ammunition for compliance with Range requirements, and your ability to comply with Range Safety Rules in using the facility. You will be advised of any deficiencies prior to granting of full membership.

**I have read and signed this information form, the Willful Participation Agreement, and the Range Safety Rules. I consent to a search of criminal history record information to insure that I am not a felon or otherwise barred from membership if deemed necessary by the Club. I agree that any false statement or misrepresentation given in connection with this information form, any violation of Range Safety Rules, or any failure to obey the commands of a Range Safety Officer may be grounds for expulsion from the Range and termination of membership privileges.**
